**VOLUNTARY ANNOUNCEMENT
REGARDING EPIDEMIC CONTROL MEASURES IN CANADA**

This announcement is made by CTEH INC. (the “**Company**”, together with its subsidiaries, the “**Group**”) on a voluntary basis. The purpose of this announcement is to keep the shareholders of the Company (the “**Shareholders**”) and potential investors informed of the latest business development of the Group.

In view of the outbreak of the novel coronavirus pneumonia epidemic (the “**Epidemic**”), the government of Canada (“**Government**”) has implemented a number of measures to control the spread of the Epidemic (the “**Epidemic Control Measures**”). The Epidemic Control Measures include, among others, the closure of Canada-U.S. border to non-essential travel from March 21, 2020 for 30 days and closure of the non-essential businesses in Ontario and Quebec, Canada from March 25, 2020 for 14 days, which are expected to affect the daily operation of the Group and bring adverse impact to travel industry in North America. It is expected that the Epidemic Control Measures will continue until the Epidemic eased.

The principal businesses of the Group include (i) air ticket distribution; (ii) travel business process management; and (iii) travel products and services. As the operations of the Group in Ontario and Quebec, Canada are not classified as “essential businesses” under the executive order, retail branches and office of the Group in Ontario and Quebec, Canada are temporarily closed during the period. The Group has adopted a work from home policy for all employees, requiring them to work remotely from their homes to maintain the operation of the Group. Thus, the Epidemic and the Epidemic Control Measures is expected to have a significant adverse impact on the business and financial performance of the Group.

The Company will closely monitor the Group's exposure to the risks and uncertainties in connection with the Epidemic. The business and financial performance of the Group may be further affected if additional Epidemic Control Measures, including more stringent travel restrictions and extension of the operation suspension period of the non-essential businesses in Ontario and Quebec, Canada, are pronounced by the Government in response to the new development of the Epidemic.

Shareholders and potential investors of the Company are advised to exercise caution when dealing in the shares of the Company.
